**Summary: This letter is a formal cease and desist notice regarding unfounded copyright claims and unlawful business obstruction. I request written confirmation that CST does not assert copyright claims over my public domain publications and that related takedown requests by Bridge Publications and New Era Publications be withdrawn within seven days.**

## **Subject: Cease and desist letter due to unfounded claims of copyright infringement and business interference**

Dear Mr. Bellin,

It has come to my attention that false copyright claims have been made against my publications by your organization or companies associated with you – in particular **Bridge Publications, New Era Publications International (NEPI) and Religious Technology Center (RTC)**. These unfounded allegations have led to my books being blocked from various distribution platforms, including **Amazon KDP** and **Ingram Spark**, without legal basis.

The works I have published are in the public domain and are not subject to your organization's copyright protection. I therefore demand that you immediately distance yourself from these blocking measures and provide written confirmation that **CST itself does not own or assert any rights to these works**.

Furthermore, I demand that you ensure that **Bridge Publications** and **New Era Publications International (NEPI)** withdraw the complaints they have filed with **Amazon KDP** and **Ingram Spark** and arrange for the unlawfully blocked titles to be released within **seven days**. These companies have relied on false copyright claims, even though CST – as the parent company – is not entitled to claim these works.


Furthermore, I demand that CST officially instruct **all subordinate organizations and licensees** to refrain from any future obstruction of my business activities and to refrain from making any further unfounded copyright claims against my works.

Should I not receive a **binding declaration** within the set deadline, I will be forced to take legal action. This includes, among other things, a **lawsuit for injunction and damages**, as well as a public accounting for this case. I would like to point out that this is not the first time that Scientology organizations have tried to suppress unwanted publications by abusively asserting copyrights.

The unlawful obstruction of my legitimate business activities constitutes an **unfair business practice** that violates both international copyright law and fair trade practices. I therefore strongly recommend that you immediately withdraw the unlawful claims in order to avoid further damage.

**I expect your written confirmation by 11. March 2025 at the latest by email or post.**
